The presenters shared that the sail club is participating in the Midwest Interscholastic Sailing Association- East Division. They explained that the Lansing Sail Club has been very helpful getting our club up and running and M.S.U. Sail Club has generously allowed the club to use their sailboats and equipment. Bath Community Schools is the first full team in Mid-Michigan, other districts have cooperative agreement with other districts to make a team. The sail club is available to seventh and eighth graders for practice and competition for ninth through twelfth grade. The sail club is starting fundraising so that they can own and maintain their own equipment and hope to grow the program.

b. Bath School Museum Committee – Ms. Kate Hagerman and Mr. Chris Hagerman presented to the Board, a plan that the Bath Museum Committee has been working on to preserve the cupola. They shared three different proposals with various pros and cons including estimates for cost. The museum committee would like to have this completed prior to or close to the one-hundred-year anniversary of the Bath School Disaster. The Bath Charter Township would help maintain the facility and the museum committee would like to become a 501c to cover the remaining expenses and be self- sufficient.
