- a. Business
 - i. State Aid Borrowing

"Motion to approve resolution authorizing issuance of notes in anticipation of state school aid (August Borrowing through the Michigan Municipal Bond Authority) in the amount of \$850,000 for the 2020/21 school year."

Discussion: Ms. Cook stated that every year, the Board of Education has borrowed funds in order to meet payroll and other financial obligations based on State Aid payments and cashflow needs. A projection for revenues and anticipated expenditures for the entire 2020/21 fiscal year has been compiled. Based on those projections, it is recommended that the Board authorize a resolution to borrow \$850,000 through the Michigan Municipal Bond Authority.

Discussion: The 2020/21General Fund Budget is presented to the Board of Education for their approval. The budget uses multiple assumptions for revenues and expenditures and will be subject to review and amendments as more information becomes available with the fall pupil counts. Factors encompass retirement and insurance projections as well as revenue adjustments. The budget will be amended in November, April and June of next year as more information on revenues and expenditures becomes clear.
