iii. Proposed High School Elective Additions

Background: **LEADERSHIP 101** This is a service leadership based class so there is not a preset curriculum for the entirety of the course. The students learn leadership lessons (using Covey's *The 7 Habits of Highly Effective Teens*) and apply leadership skills to service based projects they develop in small groups (using the Action Plan). Here are the links for the curriculum for The 7 Habits lessons and the Action Plan:

LIFETIME MATHEMATICAL DATA (Data Science Class) I am attending the training (in Grand Rapids, July 23-28) for this course to bring it to Bath HS this fall. This is what we have so far for the course, but it is subject to change, once I attend the training. Matt Stephens will be teaching the course for the 2023-24 school year. MDE is in the process of approving this course to be an alternative to Algebra 2 graduation requirement.

OFFICIATING This is a MHSAA aligned semester course and uses MHSAA approved curriculum.

OUTDOOR ADVENTURE CLASS This is an outdoor physical education course designed to get students active in outdoor activities.

Background: The Middle School would like to adopt Into Math published by Houghton Mifflin Harcourt for the 2023-2024 school year.

The middle school math team reviewed a number of curriculums the last two years, piloting Into Math the second semester of the 2022-2023 school year. The tiered program provides support for learners at various levels (above and below grade level), as well as multiple formative assessments to monitor student understanding throughout each unit.

Into Math supports a growth mindset to encourage positive math thinkers, as well as Social Emotional Learning needs. Students are able to monitor personal growth and set goals based on feedback and performance.

A Spanish version is available for our ELL population.

Professional development will be provided for instructors before and during implementation.
